Program Insights

The Practical Nursing Program is a 12-month diploma program, which consists of a combination of classroom, laboratory and clinical experiences. These experiences expose the student to the wide variety of tasks and responsibilities required of today's practical nurse. Upon completion of the program the student is prepared to take the State Board of Nursing Exam, and may upon passing become a Licensed Practical Nurse.

Classroom and clinical instruction teaches students how to provide basic bedside care. They become skilled in taking vital signs such as temperature, blood pressure, pulse, and respiration. They also learn to treat bedsores, prepare and give injections and enemas, apply dressings, and report adverse reactions to medications or treatments. In addition to providing routine bedside care, LPNs in nursing homes may also help to evaluate residents' needs, develop care plans, and supervise the care provided by nursing assistants.

Career Outlook

Employment in this occupation is expected to increase faster than the average for all occupations in response to the long-term care needs of a rapidly growing population of elderly people, and to the general growth of health care.

ADMISSION

Applicants seeking admission to the Practical Nursing program must:

- a. Make application for admission to the Technology Center.
- b. Submit evidence of high school graduation or GED equivalency.
- c. Attain passing scores on the HESI Test.
- d. Complete & submit PN packet by deadline.
- e. Upon acceptance to the program, submit evidence of a recent physical examination by a licensed physician or nurse practitioner.
- f. Report for enrollment upon notification of acceptance.
- g. Complete and successfully pass a background check.
